Role Summary

- Work closely with the Construction Manager and be responsible for managing & enabling construction activities required from the strategy, including Tier 2 engagement and integration/ collaboration, in accordance with the construction programme
- Ensure the relevant safety, quality & environmental management system is implemented, that it is kept up to date & that site resources, inclusive of subcontractors, have the correct competencies
- Ensure project handover is completed to the required timescales & delivery milestones
- Request the correct resources from the Construction Manager in a timely manner to meet programme demands
- Contribute to the ROV process where required
- Communicate, & maintain a working relationship with the Delivery Assurance manager (DAM) to maintain CSIR, CEIR & CQIR compliance & other construction assurance requirements.
- Take ownership of the re-work list at DM3, develop, & ensure items are completed in a timely manner
- Responsible for ensuring the re-work list is submitted to the mailbox before the required date
- Manage the work to ensure that it has been undertaken to the required standards achieving a defect free end result whilst maintaining Client satisfaction through Safe to operate (STO), and handover at DM4
- Identify where training is required or requires renewal
- Work closely with the Cost Manager to manage budgets and be responsible for site expenditure in line with budget, focussing on the efficiency challenge and outperforming on the overall out-turn cost for a project
- Approve weekly timesheets and submit in the required timescales
- Review and approve subcontract RAMS documentation as and when required
- Ensure plant utilisation and verification on site is completed
- Ensure Goods Received Notes (GRN) processes are followed
- Place requisitions with home organisation, when authorised, for budgeted items required
- Confirm sub-contract orders are in place. Manage and control non-conformance reports
- Lead and facilitate the Supply Chain HSP04 meetings, record minutes and distribute to the Project Delivery Team
- Working closely with the Project Delivery Team, follow the Technical Query and Design Change process through Stage 4 - Assembly through to Project Handover
- Work closely with the Project Delivery Team to provide relevant information to enable accurate and timely reporting on project cost, programme, quality/design, safety.
- Manage construction risk & opportunity effectively - take responsibility for the identification, allocation & management of the project risk & opportunities, taking effective mitigation measures to reduce risk
- Ensure production management is implemented
- Liaise, & work closely with the Cost Manager & Project Delivery Manager to accurately forecast out-turn costs
- Ensure compliance with scheme governance - out-turn movement, provide information to the Cost Manager
- Embrace use of CCMS within the Alliance as part of an integrated project team ensuring that CCMS is operated correctly and effectively for both costs management and purchase to pay
- Provide the IPL/ PDMs/Construction Managers / Operations Managers with progress reports, HSQE performance & support at meetings
- Lead the site team to deliver their responsibilities. Ensure teams are focused to meet customer’s requirements & project objectives – provide overall guidance & support to the site team to ensure project success. Ensure the team works in a structured & cohesive way. Manage poor performance within the site team
- Liaise with AW Operational staff to ensure the site is fully compliant at all times to enable a seamless transition of asset ownership
- Have knowledge of the Standard Product Catalogue, be open to innovative ideas & techniques
