Environmental Consent Advisor

The Role:

Within one of our frameworks we have the requirement for an Environmental Advisor/ Consents person. The role involves supporting the framework manager to ensure consents are applied for and in place prior to works taking place. The post-holder will act as the regional champion and will provide support to the existing HSEQ advisors where necessary.

Produce and report on framework customer performance ie. 3 Pillar Measures, on a monthly basis

Maintain external liaison and learning, and circulate
Identify environmental good practice for inclusion in Company communications
Develop and deliver environmental training courses

Monitor and review environmental performance data to drive improvements
Undertake site inspections and audits to programme
Undertake incident investigation to learn lessons and implement improvements
